**PARENT/GUARDIAN CODE OF CONDUCT
AGREEMENT**

As a parent/guardian in the Manor Youth Association, I pledge to show good sportsmanship to our children, their team, and to the league by supporting everyone — players, coaches, officials — at all games and practices. In addition to showing good sportsmanship over any personal desire to win, I will ensure that the game is for the benefit of the kids and their athletic development.

As a parent/guardian in the Manor Youth Association, you agree to abide by and follow the rules and guidelines below:

- I will adhere to the Manor Youth Association Zero Tolerance Policy. I will never be under the influence of/or in the possession of drugs, alcohol, tobacco products, or weapons of any kind during games and practices.
- I understand that the use of foul language towards anyone (coaches, teammates, opposing team players, umpires, or spectators) will not be tolerated. I will not engage in any language or actions intending to initiate, hurt, intimidate, or humiliate anyone. I will also not tolerate these actions from others associated with the Manor Youth Association.
- I will not post on any social media site with the intent to initiate, hurt, intimidate, or humiliate anyone. Negative, demeaning, or derogatory posts/comments will not be tolerated as this is considered harassment. Violations of this policy will result in disciplinary action.
- I (and my guests) will not engage in any kind of unsportsmanlike conduct including but not limited to booing, taunting, or using profane language or gestures. My goal is to maintain self-control during all games and practices.

- It is my responsibility (and that of my guests) to set a positive example for my child by displaying respect, courtesy, and showing positive support during games and practice for all coaches, players, umpires, and spectators.
- I will cooperate with league officials and team representatives. If at the time there is a dispute, it should be petitioned through the proper channels and will be handled accordingly.
- I will encourage my child to play by the rules and to resolve conflict without resorting to hostility or violence. It is my job to ensure my child treats everyone with respect.
- I will support the coaches and allow them to do their job by not coaching my child or other players during games and practices. I will not openly question or confront coaches before, during, or after games or practices. I will take the time to speak with coaches about any concerns calmly, privately, and at an agreed-upon time and place.

I realize that if I violate this Code of Conduct I may be subject to disciplinary action that could include, but is not limited to the following:

- Verbal warning by the Head Coach and/or Manor Youth Association Board of Directors
- Written warning
- Parental game suspension with written documentation of incident kept on file by the Manor Youth Association Board of Directors
- Parental season suspension
- Parental suspension from all future Manor Youth Association games (Home or Away), practices, and fields
